
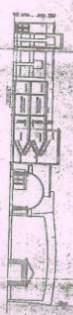


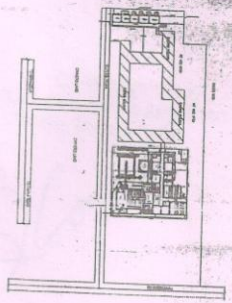

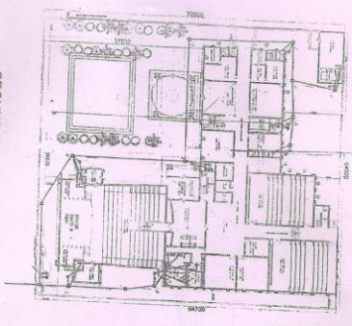
FRONT ELEVATION



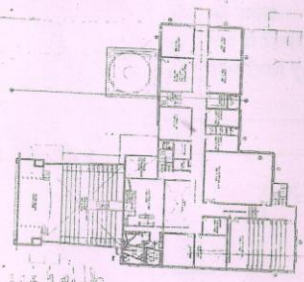

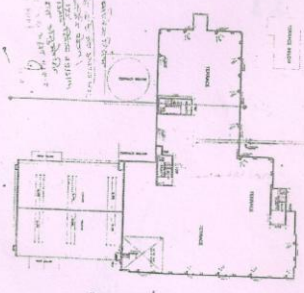
SITE PLAN - N
